I, hereby apply for membership at the MK Tactical, LLC, Gun Club. I certify that I am a person of good repute and that I have never been convicted of any felony or any other crime of violence. I have read, understood, and signed the agreement. I understand that this application is conditional and will be reviewed by management for approval prior to issuance of credentials. If I am admitted to membership, I will fulfill the obligations of good citizenship and good sportsmanship. I understand that failure to comply with any of the policies and/or rules of the club may result in the termination of my membership.

The management reserves the right to run a background check on a new applicant. Proof of purchase of a firearm in our Pro-shop within 3 months prior to application, a CHL license or law enforcement accreditation might substitute for the background check.

For your application to be considered, the agreement must be signed in TWO (2) places as well as initialed as to your choice of options on our privacy policy. It must be accompanied by your remittance of the enrollment fee. All memberships are Lifetime Memberships so long as monthly or annual dues are paid. If dues have not been paid for less than one year, membership can be reinstated upon approval of the Management, by paying all unpaid monthly or annual dues.

Enrollment and Membership fees

Monthly Full Single Membership:

\$250 one time enrollment fee for “Founders members” \$350.00 after range opened.
Monthly fee after range is open is \$35 for “Founders” and \$45 for regular members.

Monthly Family Membership up to 4 people:

\$550 one time enrollment fee for “Founders members” \$700.00 after range opened. Monthly fee after range is open is \$65 for “Founders” and \$75 for regular members. Family means a couple and their children (Up to 21 years of age). Each additional child is \$15 month.

Monthly Couples Membership:

\$450 one time enrollment fee for “Founders members”. \$600.00 after range opened.
Monthly fee after range is open is \$55 for “Founders” and \$65 for regular members.

Active Military Membership:

20% discount on enrollment and monthly fees. 10% for veterans. Military memberships can be put on hold for the time of deployment.

Active Law Enforcement Membership:

20% discount on enrollment and monthly fees. 10% for veterans.

Corporate Memberships:

Corporate Memberships are owned by the company and can be transferred once a year after notice is given to the range management. The corporation has to purchase a minimum of 5 single memberships. “Founders” corporate memberships are \$200/person enrollment fee and \$35 monthly/person. Regular memberships are \$300/person enrollment and \$40 monthly/person. A minimum of 5 memberships has to be maintained to keep corporate membership status.

Gold Lifetime Membership:

Single Membership ” Founders”: \$4000 (\$500 payable at signup , \$3500 4 weeks before Range opens).

Single Membership ”Non Founders”: \$5000 (\$1000 payable at signup , \$2000 payable 12 month after signup and another \$2000 payable 24 month after signup).

Please ask for Gold Couples and Family Memberships.

Enrollment Fee:

This fee pays your initiation into the Club, and does not cover required monthly fees.

“Founders” members:

Everyone who signs up for the range before the lot is purchased is considered a “Founders” member. “Founders” enrollment period might be ended by management at any time.

Additional “Founders” bonus: Your first firearm purchased at our Pro-shop is sold to the “Founders” member at cost.

Discounted and “Founders” memberships can only be resold with the approval of management.

A receipt and temporary membership card will be issued to you to use at the range for membership privileges while your application and permanent membership card are being processed.

Membership Agreement

I agree to all conditions of membership listed in this agreement. I understand that violation of any item may lead to investigation by the Management of the Club. This could result in a warning or a termination of membership as per the Club's rules.

1. I will handle firearms and other equipment safely at all times.
2. I will obey all directives of the Range master or staff.
3. My behavior at the Club's facilities will be courteous and non-confrontational.
4. I will conduct myself in accordance with good sportsmanship at all times.

All members have the following responsibilities:

1. Not to act in a way that brings harm to the Club.
2. Not to act in a way that interferes with the ability of another to use or enjoy the facilities of the Club
3. Not to make false statements relating to the Club.
4. Not to misrepresent oneself as an agent of the Club nor act in such a way that others may assume he/she is an agent of the Club.
5. Not to create a potential safety violation.

I agree to hold harmless MK Tactical, LLC and its Gun Club and their management and employees from and against any and/or all loss, liability, expense, claim, costs, suits and/or damages of every kind, nature and/or description resulting directly or indirectly from my use of the Club's facilities.

Any member or shooter who is observed by MK Tactical, LLC and its Gun Club to be violating safe firearms practices, rules of the club or common good sportsmanship may have their range and/or shooting activity suspended immediately – pending a review by Club Management. The length of suspension will be determined by Management.

Membership benefits may be indefinitely suspended.

Access to Club facilities will be denied to any member or nonmember whose use of privileges has been suspended for a safety violation or a violation of Club rules.

PARTICIPANT AGREEMENT, RELEASE, AND ACKNOWLEDGMENT OF RISK

For Participants and Observers

In consideration of the services of MK Tactical, LLC, Gun Club, their agents, owners, officers, volunteers, participants, employees, and all other persons or entities acting in any capacity on their behalf (herein after collectively referred to as "MKGC"), I hereby agree to release and discharge MKGC on behalf of myself, my children, my parents, my heirs, assignees, personal representatives and estate as follows:

1. I acknowledge that target practice at a shooting range entails known and unanticipated risks which could result in physical or emotional injury, paralysis, death, or damage to myself, to property, or to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity.

The risks include, among other things: participation may result in the undersigned or third parties being shot by a firearm; suffering hearing loss; eye injury or loss; inhalation or contact with airborne contaminants and/or flying debris, slipping or falling on uneven or loose flooring and objects.

Furthermore MKGC employees have difficult jobs to perform. They seek safety, but they are not infallible. They might be unaware of a participant's fitness or abilities. They may give inadequate warnings or instructions, and the equipment being used might malfunction.

2. I expressly agree and promise to accept and assume all of the risks existing in this activity. My participation in this activity is purely voluntary, and I elect to participate in spite of the risks.
3. I hereby voluntarily release, forever discharge, and agree to indemnify, and hold harmless MKGC any and all claims, demands, or causes of action, which are in any way connected with my participation in this activity or my use of MKGC's equipment or facilities, including any such claims which allege negligent acts or omissions of MKGC.
4. Should MKGC or anyone acting on their behalf be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs.
5. I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or else I agree to bare the cost of such injury or damage myself. I further certify that I have no medical or physical conditions which could interfere with my safety in this activity, or else I am willing to assume-and bare the cost of all risks that may be created, directly or indirectly, by any such condition.
6. In the event that I file a lawsuit against MKGC, I agree to do so solely in the state of Oregon and County of Washington and I further agree that the substantive law of that state shall apply in that action without regard to the conflict of law rules of that state.

PARTICIPANT AGREEMENT, RELEASE, AND ACKNOWLEDGMENT OF RISK

By signing this document, I acknowledge that if anyone is hurt or property is damaged during my participation in this activity, I may be found by a court of law to have waived my right to maintain a lawsuit against MKGC on the basis of any claim from which I have released herein.

I have had sufficient opportunity to read this entire document. I have read and understood it, and I agree to be bound by its terms. I agree that if any portion of this agreement is found to be void unenforceable, the remaining portion shall remain in full force and effect.
